ORC Report: Kirk reported:

He looked for leak in Dan Sullivan's field and the wet spot dried up the next day. He found a place where Bone Mesa's vault may be and he will ask for help from John Morrell. The Board decided to prioritize asking Dick Kendall to excavate the area to look for the vault. He checked 3850 Rd. after a tap holder reported a possible leak.

He walked the Eagle Butte line looking for a leak after a renter reported low pressure issues. Dick Kendall found and repaired a large leak on K25 Rd.
